## Legion now sponsoring veteran gaming community

The American Legion | July 6, 2023



Since first collaborating for an online Call of Duty tournament in late 2021, The American Legion and REGIMENT Gaming have teamed up multiple times, including an in-person Memorial Day tournament and REGIMENT setting up a gaming station display during the 2022 National Convention in Milwaukee. REGIMENT also teamed with Paradox Customs to provide a gaming station to American Legion Post 3 in Moundsville, W.Va.

But the relationship between the nation's largest veterans service organization and the nation's largest veteran gaming community has now reached a new level. On July 1, it was announced that The American Legion is now the official veteran service organization of REGIMENT Gaming.

"This is a great opportunity for The American Legion to team with a growing entity in the veteran community, and one with a younger demographic," said Dean Kessel, The American Legion's Chief Marketing Officer. "While they joined as gamers, members of REGIMENT also are about looking out for each other and supporting each other. That's the mission of The American Legion, especially through our Be the One suicide-prevention initiative, so this is a great

way to share that mission across both organization's platforms."

REGIMENT co-founder and CEO Chris Earl said having the Legion partnered with his creation "is surreal. Everyone knows who The American Legion is and having them watching our six brings a lot of validity to what we're doing here. We are beyond grateful and excited for this opportunity.

"REGIMENT has done an amazing job at uniting veterans through the power of gaming, but now it's time to get these guys and girls to put down the controller and go outside and connect with veterans in person. Working with The American Legion and their posts is going to help us accomplish that."

Similar thoughts were shared by Regiment co-owner and President Brandon Hatfield, who called the partnership "a huge accomplishment for REGIMENT and something we have been working towards since the start of the organization. The American Legion is a name that I've known since I was young, so it's personally really cool to see our brands working together. "The American Legion was a brand on our radar since the start of REGIMENT, so I was hopeful to see an official partnership working together. We are working towards some of the same goals, and it's cool to see the Legion recognize gaming as a viable tool to unite veterans and servicemembers."

Earl said the average age of a REGIMENT member is 24 years old; both he and Hatfield feel the relationship between the gaming community and The American Legion can assist in the Legion's effort to bring in younger members.

## **Putting Be the One first**

American Legion Post 180 in Vienna, Va., celebrated the nation's birthday while conducting outreach to support those who swore to protect our nation with their lives.

More than 35 American Legion Family members and community supporters participated in the post's third annual Celebrate America 5K, which was combined with The American Legion Be the One initiative. The July 1 run-walk event was among the initial post events held on the first of the month, intended to be a specific day to raise awareness in communities throughout the nation, per Resolution 13, approved by the National Executive Committee.

The Be the One initiative's goal is to reduce the rate of veteran suicide by raising awareness about the issue, empowering everyone to take appropriate action, and connecting veterans with fitness and wellness opportunities. American Legion National Commander Vincent "James" Troiola has made the initiative a priority, encouraging posts and members to find ways to raise awareness in whatever way fits best in their communities.

"Fitness and wellness go hand-in-hand with the Be the One campaign," Post 180 First Vice Commander Dave Wallace said. "Be the One to listen. Be the One to reach out. Be the One to stop one veteran from committing suicide. Having the wellness side has been proven to be the key factor in an individual's mindset. So having this event just made sense."

Past National Commander Dan Dellinger was among the participants.

"Post 180 has taken to heart the program by National Commander Troiola," he said. "Be the One is very important to help stop veterans suicides. If you see something or hear something, say something.

Dellinger noted the post is aiming to bang a continuous drumbeat of spreading the word throughout the community.

"We have a large veterans community here," he explained. "We are going to try to do something on the first Saturday of every month to promote (Be the One.) We are going to try to continue to do this as much as possible.

After all, Dellinger concluded, Be the One drives toward the heart of The American Legion's dedication to helping fellow veterans.

"Every servicemember had a battle buddy. We stood beside them in battle. We need to make sure we stand beside them today."

Post member Mike Paruti organized the 5K, which started and ended at the post. Participants received information packets about the Be the One, which was also highlighted on the keepsake T-shirt. (Visit, access and download promotional materials at the <u>Be</u> the One resources page.)

"Be the One is, of course, a very special message," said Paruti, noting that this year's 5K is the first held since 2019. "It's very special that we rebirth this event with the Be the One message. Hopefully, they take away that message and understand how easy it is to Be the One. If you see any signs of where the message might apply, act on it."

Paruti was pleased with the turnout.

"It was great to have everyone come out, a mix of young, old, fast, slow, veterans, non-veterans. Everyone supports the military, which is great. But it's great to know that there are so many people who support our military, The American Legion, and our post in this community."

Vienna Mayor Linda Colbert was among Legion Family members and others from the community who walked the 5K.

"I love to support The American Legion and whatever event they are doing, and I love to be here and support them," she said. "I'm all about being healthy and doing things to support our town. I also love seeing people here being so patriotic."

Post 180 is the service organization with the longest tenure in its town, Wallace said. That dedication to community is seen in its various community events not just for the Fourth of July but throughout the year.

"This also allows us to show how we educate the children, our different programs that can reach out to them with Boys State, Junior Law Cadet program and others, and remind everyone who we are and what we can bring to the community," he explained.



Pentagon report: Military suicides rose in 1st quarter of 2023 compared to same time last year

Suicides in the active-duty military increased in the first three months of 2023 compared to the same time

last year, according to a newly released Pentagon report.

The Defense Suicide Prevention Office revealed in its quarterly report that the overall number of active-duty suicides — 94 — from January through March was up 25% compared to the number of troops — 75 — who took their own lives in the first three months of 2022.

"Every death by suicide is a tragedy," according to the report. "Data includes all known or suspected suicides (both confirmed and pending) as of March 31, 2023."

The Army had the greatest increase in suicide deaths, from 37 to 49. The Marine Corps increased from eight to 14. The Air Force had one additional suicide compared to 2022 and there was no change for the Navy or Space Force, the Defense Department report states. The 94 active-duty suicides are the most that the military has seen since 97 were reported in the second quarter of 2021. Among reserve troops and the National Guard, the report said suicide figures did not change between the first quarter of 2022 and the same period this year.

Pentagon data have shown a rise in military suicides in the past decade, including a significant spike in 2020 during the coronavirus pandemic, and the Defense Department has spent millions of dollars on efforts to try to prevent them.

In May, the department enacted the long-awaited <u>Brandon Act</u> to let troops seek mental health services confidentially and any time that they need it. It's named after Navy Petty Officer 3rd Class Brandon Caserta, who committed suicide in 2018. According to Defense Department data, there were almost 29 suicides per 100,000 troops in 2020 — up from 17.5 per 100,000 in 2010. That figure fell to 24.3 per 100,000 in 2021, but it still represented a serious uptick in suicides compared to most of the 2000s and 2010s.

"There is still a gradual increasing trend for suicide in the military over a 10-year period, and we need to see a sustained long-term reduction in suicide rates to know if we're really making progress," Beth Foster, executive director of the Pentagon's Force Resiliency Office, said when the 2021 Annual Report on Suicide in the Military came out in the fall.

The Defense Suicide Prevention Office was created by a Pentagon task force in 2011 to find more effective suicide prevention methods. Earlier this year, the Pentagon's Suicide Prevention and Response Independent Review Committee, after studying the problem for a year, made several recommendations, including restricting troops' access to firearms, imposing waiting periods for gun and ammunition purchases and raising the minimum age for buying both to 25. Firearms are used in about two-thirds of all active-duty military suicides, according to the Defense Department. The Pentagon is reviewing the recommendations.

The second quarter ended June 30 and the Defense Suicide Prevention Office traditionally doesn't issue an updated suicide report covering that period until October. The Pentagon's comprehensive yearly study on military suicides also is typically released in October. This year's will analyze 2022.

"The numbers presented in this report are preliminary and subject to change as previously unknown suicide cases are reported and some known cases are further investigated," the four-page report states. "Caution should be used when making comparisons across groups and/or interpreting changes in suicide counts across time."

In addition to Pentagon-wide programs, each of the military services has its own suicide program designed to provide help for troubled troops. Further, the national suicide prevention hotline was <u>streamlined last year and became available by dialing 988</u>. Pressing "1" after calling the number takes callers to the Veterans Crisis Line. Service members and veterans can also text 838255 or visit VeteransCrisisLine.net for help.

You may or may not have heard, but The American Legion has finally granted our request to allow the Sons of The American Legion to Certify our own VAVS Representatives and Deputies at VA Hospitals and Medical Centers across the Country! This resolution was passed by the SAL at the Fall 2022 NEC Meeting, with subsequent approval by TAL at their Spring meetings. This has been a major undertaking by our VA&R Commission over the last couple of years, and is a major accomplishment for all of us with The Sons of The American Legion!

There is a large untapped need at every VA across the Country for volunteers, support, and the fulfillment of needs for our Veterans. This is now our opportunity to fill those needs without time delays, unnecessary red tape, and extraneous levels of approval that only delay our mission. Simply stated, a VAVS (Veterans Affairs Voluntary Service) Representative and/or Deputy appointment allows our Organization to have a "liaison" to a VA facility. That individual then communicates what needs there are to fill and what ways there are that we as Sons can help, in each and every VA.

Attached is a short brochure describing the role of a VAVS Representative and/or Deputy. It is a volunteer position that is available at <u>EVERY VA FACILITY</u>, with over 155 facilities in the U.S. Each VA can have 1 Representative from the SAL and multiple Deputies. The Sons of The American Legion is currently 1 of only 41 Veteran and/or Community Service Organizations that is authorized by the Dept. of Veteran Affairs to be a member of the National Advisory Council, providing these positions and services at VA facilities.

It has been a cumbersome process to appoint VAVS Representative and Deputies up to this point, but that has now ended with our new ability to certify these positions across the Country. A Certification form is also attached to this email. An appointment to a Representative or Deputy now only requires the approval of the Detachment Adjutant and Detachment VA&R Chairman. Note: Associate positions are for a Representative or Deputy who will be at a VA that is in a neighboring State from his Detachment.

PLEASE, PLEASE, PLEASE, identify 1 or 2 individuals to serve in these capacities at your neighboring VA. If you have 5 facilities within your Detachment, then line-up members for each of the 5. This is such an important role, and is so important that we build on what we have. We currently have Representatives and/or Deputies in 31 VA facilities across the Country. **That means we need to fill the other 124!** 

Please let us know if you have any questions, or need further assistance in making this happen.

## Palou's incredible roll continues with win at Mid-Ohio

Just when it seemed Chip Ganassi Racing's (CGR) Alex Palou couldn't look any more dominant, he did. And the result was another win in the No. 10 American Legion Honda.

In Sunday's Honda Indy 200 at Mid-Ohio, it was again Palou controlling the end of the race, to the point where the television broadcast was more focused on closer battles for positions eight and lower.

He wound up finishing 5.0242 seconds head of CGR teammate Scott Dixon, leading the final 24 laps of the race.

It was Palou's third straight win and fourth in five NTT INDYCAR SERIES races – three of those in Legion's Be the One No. 10. Only twice since 2016 has a driver won three straight races in the series, with the last being Dixon in 2020.

"Third win in a row for the No. 10 car, super special to do it here at Mid-Ohio where we've been good in the past," Palou said via CGR media. "We needed that win, and it's a special weekend for Honda. We had all the power and fuel mileage we needed to make our strategy work. We went long and just ran really fast lap times to get to Victory Lane. We did it and we're going to keep it going with The American Legion."

Palou took his first lead on lap 28, led again laps 31-53, and then took his final lead on lap 53 after passing polesitter Colton Herta and No. 2 qualifier Graham Rahal. His lead grew to as many as eight seconds the rest of the way.

"I had a good car and good strategy, honestly," Palou said. "We've got a really fast car, (but) we knew we needed to try something different to the guys starting up front – that's why we started on primary (tires). Everything went well. The strategy, the pit stops, and our pace was pretty good."

Palou's lead in the INDYCAR SERIES points standings ballooned to 110 points over the second-place Dixon. Also worth noting is the past three times an INDYCAR driver won three races in a row – Dixon in 2013 and 2020, and Simon Pagenaud in 2016 – they went on to take the series championship.

"I know we can have some good couple of races coming up now, and we'll still try and maximize (points), do the best we can and win when we can," Palou said. "So, yeah, try and get (the car) on top."

Rookie Marcus Armstrong had another strong weekend while carrying American Legion branding on his No. 11 Ridgeline Lubricants Honda. After qualifying 18th, he was able to move up nine spots by the close of the race, increasing his lead in the INDYCAR SERIES rookie points race.

"It was a good race," Armstrong said. "In the end, we made up a lot of track position there by just staying out and doing fast laps. We did that for the rest of the day, that same strategy, and it paid off. The team did a great job in pit lane. Blair, Eric, and the rest of the

crew did a great job on pit wall. I just drove as fast as I could, it turned out well, but we can do better next time."

Also carrying American Legion branding was Marcus Ericsson, who entered the race second in the points standings. But Ericsson was involved in an on-track incident with Felix Rosenqvist on the opening lap of the race that forced the No. 8 Huski Ice Spritz Honda back to the garage for repairs. After briefly returning to the race track at the halfway mark, the No. 8 car was forced to retire as a result of the damage sustained in the first lap crash, leading to a 27th-place finish. Ericsson still sits at fourth in the series championship.

"At the start, I thought I had more grip there, but bumped into Felix's tire and went over his car," Ericsson said. "It's very disappointing for the No. 8 car and crew, as well as Felix. It was never my intention, obviously, so I feel really bad for him. Congrats to the team on the 1-2 finish."

In the INDY NXT race earlier in the day, Chip Ganassi Racing developmental driver Kyffin Simpson recorded his best finish of the season and put together maybe his best overall weekend behind the wheel of the No. 21 HMD Motorsports/Ridgeline Lubricants featuring American Legion branding. After topping the weekend's second practice session, Simpson was able to qualify third for the Firestone Grand Prix at Mid-Ohio.

Simpson ran near the top of the field the entire race and then used a late restart to pass Christian Rasmussen and score a second-place finish behind Louis Foster. The performance moved Simpson from 13th to ninth in the INDY NXT points standings.

"The HMD crew gave me a great car this weekend," Simpson posted on Instagram. "I felt comfortable from the first lap and even with all the safety cars, rain, and the pressure from behind, we didn't make any mistakes. Hard but fair racing all round and I gave it everything chasing Louis down for the win. Didn't quite have enough laps to get there... P2."

Next up for CGR and the rest of INDYCAR is the Honda Indy Toronto street course on Sunday, July 16.

"Gaming is a powerful industry that brings people together, and this community helps people overcome obstacles in their life," Hatfield said. "It's a unique way to allow REGIMENT to grow The American Legion. REGIMENT started from nothing just a few years ago to becoming one of the largest gaming communities in the industry, and we aim to help bridge the gap for the Legion and veteran gamers.

"The Legion's resources and connections will help REGIMENT expand and offer even better support for our veterans. I look forward to the collaboration of our two brands and can't wait to see veteran lives changed because of this partnership."

Already, members of REGIMENT have taken to social media to share news of them joining a local American Legion post. The goal, Earl said, is to grow that relationship.

"Both organizations are extremely different, but at the end of the day, we all have the same mission," Earl said. "I look forward to working with post commanders to bring gaming to posts across the country."

William Joseph Bender III, lifelong resident of the Village of Babylon and member of the Babylon Fire Department died on May 16, 2023. He was

63 years old.

Mr. Bender grew up on Park Avenue in Babylon Village. His family said he loved the close-knit community and the people from his neighborhood who became his adopted family and cared for him as if he was one of their own, particularly the Kalpins, Mastros, Griesmers, Albaneses, and Culberts. He grew up playing Little League Baseball for Babylon and also enjoyed wiffleball games, pool parties and the way everyone on Park Avenue put up Christmas lights, said his family. "He knew Babylon was a special place," said his wife, Karen Bender. "He appreciated every part of living there.

Mr. Bender was a 1978 graduate of Babylon High School where he was a member of the band, Varsity football and baseball teams. Two years after graduation, he joined the Babylon Village Fire Department. He worked at Babylon Central Fire Alarm as a dispatcher, and then in 1982 began working for New York City EMS, becoming a paramedic as a member of the New York City EMS Bellevue Class #3, in 1985. After leaving New York City EMS, he worked for Suffolk County Medical Control as Operator #17, first at Good Samaritan Hospital, then moving to Stony Brook University Hospital in 1992 until his retirement in 2017. "My dad was always proud that he was one of the first six paramedics in Suffolk County when they started the pilot program," said his son William IV.

Mr. Bender remained an active paramedic in Suffolk County and was a member of the Babylon Fire Department for 43 years up until he was diagnosed with Lymphoma in 2022. "He was one of the best paramedics I have ever known," said Chief Matthew Arundale. "He was

the first one to step up and he was always there if anyone needed any help or advice about anything." Mr. Bender was a firefighter, paramedic, ex-captain of the Babylon Fire Patrol, ex-captain of the Rescue Squad and served as a warden for the Fire Council for many years. "It's a huge loss on all levels," said Arundale.

He also served as the Department of EMS coordinator for Babylon Village and on multiple committees during his tenure with the department. "He lived a life of service," said Mrs. Bender. "He could often be found at the firehouse, spending time visiting, "holding court" and giving advice to younger members. He wanted them all to do well in life, always encouraged them and tried to help them get good jobs. He was always willing to help anyone who needed it."

Mr. Bender was a 9/11 first responder along with many other volunteers from the Town of Babylon. His wife said his greatest legacy was instilling a sense of community into his four sons, who are following the example of service that he first set. "He was dedicated to our family, but his Stonybrook and the Babylon Fire Department families were his second loves," she said, adding, "He was very passionate about the Babylon Rescue Squad's mission of caring for people."

He was an active member of St. Joseph's Church, and a member of the Sons of the American Legion Post 94 in Babylon. When he was not working, he enjoyed traveling on vacations with his family to Lake George, Pennsylvania, Virginia, and Florida and would reach out to former Babylon friends when he visited those places. He loved going to the movies and driving around the Village "on patrol," with friends and family, just enjoying where he lived.

He was a lifelong New York Mets fan and enjoyed all things from the 1970s era, especially the music and classic muscle cars. When he was in high school, he played the trumpet in the school band and also in a rock band for Babylon High School Presents, the annual talent show. Since he could read music, he later taught himself how to play the bass guitar. He was also a part of the band for the Babylon Fire Department. "He loved music so much," said his wife. "His favorite group was Chicago for the big band sound, and he would always sing the bass lines in his other favorite 70s songs.'

The American Legion's accredited service officers and appeals representatives are delivering for the nation's disabled veterans. After a 2022 that saw caseloads and compensation spike, the Legion's claims experts were on pace for another record year, assisting veterans free of charge, in their applications for disability benefits and cases when VA decisions are disputed.

The Legion also finished the 2022-23 membership year with more than 77,000 new faces, recruited traditionally into local posts. That number exceeded the goal set by American Legion National Commander Vincent J. "Jim" Troiola when he was elected last September.

Scholarship dollars, flag queries and congressional testimony on the need to reduce veteran suicide rates topped the June 2023 Membership Impact Report.

## Georgia Legion post helps law enforcement provide life-saving care

American Legion Post 167 in Chatsworth, Ga., wanted to help the local law enforcement with an immediate need they had. Post Commander Larry Morrison called Sheriff Jimmy Davenport and asked what his officers needed – 47 advanced trauma kits for each officer's vehicle was the answer.


At a cost of \$8,200, Post 167 recently presented Davenport the 47 trauma kits.

"We couldn't think of a better institution in our local community to support," Morrison said. "About 60% of the time, they're (police officers) there before the ambulance gets there so it was imperative that they have this training and that they had the equipment to accomplish their mission" of providing life-saving care.

The 47 deputies who will benefit from the trauma kits have received advanced training in first aid and will soon complete training equivalent to that of emergency medical technicians, Morrison said, adding that Davenport was very grateful for the donation.

"When (Davenport) told me how much money it was going to be (per kit) he didn't expect me to say, 'let's go ahead and order them," said Morrison, who served as a military policeman in the Army. "He was kind of astonished.

"We really couldn't think of a better charity to give to that would help our citizens."

## VAVS REPRESENTATIVE & DEPUTY HANDBOOK

The U.S. Veterans Administration Center for Development & Civic Engagement Office or formerly Voluntary Service (VAVS), operates the largest volunteer program in the federal government supplementing staff and resources in all areas of patient support.

## **VAVS Purpose and Structure**

Purpose: To assist with the coordination of plans and policies for community participation in VA's Programs, and provide support for its needs. Membership: 1 Representative and up to 3 Deputy Representatives per certified Organization.

## **Member Selection Process**

The source for appointment nominations may vary in each Organization. Many originate at a local level, or at other levels of the Organization that are deemed responsible for a VA territory or region.

- Individuals are nominated using that Organization's nomination forms at the local and state-level as defined by that Organization.
- Final Certification is by the National Certifying Official of the Organization.

VA <u>is not</u> involved in the nomination process unless a nominee is rejected after a background check or is considered unacceptable. Appointments are not official or in effect until notice is received by letter to the specific CDCE Manager from the Organization's National Certifying Official.

## Membership Qualifications

- Be a Registered Regular Scheduled (RS) Volunteer at the VA facility.
- A sincere interest in the welfare of hospitalized and other Veterans, and a desire to help them
- The ability to work with others
- Knowledge of your organization and the ability to communicate and disseminate information
- Attend Regularly Scheduled Quarterly Meetings

### INSTRUCTIONS

### **PURPOSE:**

The purpose of this form is to certify members of The Sons of The American Legion to represent the SAL at local VA Hospitals and Medical Centers for the purpose of informing all members of volunteer opportunities and donation needs. The SAL member nominated should be familiar with the VAVS program and have the intent of serving in this vital position. A Deputy and/or Associate representative can also be appointed to assist an SAL VAVS Representative. The Associate (if applicable) is an SAL member serving the local VA in one State, but residing in a neighboring State.

### **PROCEDURES:**

- 1. The VAVS nominee must be at least 21 years of age as of the date of application. This does not affect the age of volunteers in hospitals as they are governed by the Director of the VAVS program at the VA medical facility.
- 2. The term of this appointment is indefinite, but will be terminated upon non-performance of minimal guidelines. Appointments may be made at any time with the appropriate nomination form signed by the Detachment Adjutant and VA&R Chair. Upon all approvals, the nomination form should be sent to the SAL National VAVS Representative, for final approval. Approval will also be needed from the VA&R Chair from the neighboring State, if the applicant will be an Associate Representative to the VA from that neighboring State.
- 3. Upon all approvals, the SAL National VAVS Representative will notify the appointee, all signatory, and CDCE Chief of the respective VA facility. Appointee will ensure that he be given from the VA the assignment VAVS Committee-Representative or VAVS Committee-Deputy in the case of a Deputy appointment or VAVS Committee-Associate in the case of an Associate appointment, and that his Primary Organization be affiliated with the Sons of The American Legion.
- 4. A Deputy or Associate VAVS representative is optional, but, if nominated will assist the SAL VAVS Representative in his duties as described by the Director of the VAVS program at the medical facility.

### **FORM:**

- 1. Complete all items applicable. The section "Additional Information" should be completed on nominees as to past experience or qualifications if any.
- 2. The form must be signed as indicated, with final approvals by the Sons of The American Legion National VAVS Representative.
- 3. A copy of this form should be kept by the Detachment for record purposes. Each Detachment, and the SAL National VAVS Representative, is responsible for maintaining records of their hospital representatives.
