the passage of bipartisan legislation in 2020 – authorized 988 as a new three-digit number for suicide and mental health crisis.

The lifeline is a collaboration between the U.S. Department of Health and Human Services, Federal Communications Commission, and the U.S. Department of Veterans Affairs (VA). The Suicide & Crisis Lifeline links to the <u>Veterans Crisis Line</u>; veterans who dial 988 have the option to press 1 and then speak, text or live chat with a responder.


According to Salon, more than 4.5 million calls were made to the 988 lifeline in the 11-month period ending May 31, 2023. In May alone, more than 460,000 routed contacts were made through the 988 lifeline, while 66,259 of those were routed to the Veterans Crisis Line.

Suicide is a leading cause of death in the United States. Suicide rates increased 30% between 2000–2018, declined in 2019–2020, and increased again in 2021.

# Msgr. Dino Lorenzetti



Msgr. Dino Lorenzetti, eldest priest of the Buffalo Catholic Diocese, whose priesthood spanned 70 years at several parishes and who headed the Office of Family Life for 20 years, died July 12, 2023. He would have celebrated his 102nd birthday on July 23. He lived at O'Hara Residence for retired clergy in To-

nawanda.

Born in Buffalo, the son of parents from Italy, he was a graduate of Hutchinson Central High School. He joined the U.S. Army Air Corps during World War II, fulfilling assignments in Africa and Italy, 1941- 45. When he returned, he began studies at Christ the King Seminary, then located at St. Bonaventure University, and was ordained on May 30, 1953. While pastor of Holy Cross Church in Buffalo, he welcomed the fledgling Head Start federally funded early childhood development program to open there in 1969. Holy Cross Head Start developed into one of the most successful, longest-running school readiness programs in the nation, having served many thousands of children. It has expanded into six current Buffalo locations, including the first site at Holy Cross, 150 Maryland St.

Msgr. Lorenzetti was a longtime pastor of Our Lady of the Sacred Heart Church in Orchard Park. He led efforts to purchase a former West Seneca school building to establish the parish school. It thrived to rank among the largest grade schools in the diocese. He also served at St. Mark's in Rushford, Christ the King in Snyder, St. Martha's in Depew, and Our Lady of Lourdes, St. Mary of Sorrows, and St. Louis in Buffalo. As Family Life director, he oversaw programs and educational resources for parents, children, young adults and the bereaved. In 1975, Pope Paul VI appointed him spiritual advisor to the National Federation of Catholic Physicians' Guilds, which he served until 1983. He was invited to India to address the 1978 world conference of physicians, when Mother Teresa and he were award recipients. In the 1970s, he lectured on family life education for the U.S. Air Force, Army, and Navy in the Alaskan Command.

There were nine popes and 10 bishops of Buffalo during his lifetime.

Known for his warmth, enthusiasm and upbeat personality, Msgr. Lorenzetti valued time with families. He was a respected colleague and mentor to fellow priests. "Dino loved being a priest," said Father Richard A. Reina, a close friend. "His compassion and humanity drew others to Christ, who was at the heart of his life. The joy he expressed was an inspiration to many young men considering priesthood. I know it was for me."

In 2015, he co-authored "The Agony of Betrayal," about losing his life savings to a con man who had gained his trust. Book sales benefitted Catholic Charities.

After retiring at age 75 in 1996, he continued ministry throughout Western New York, saying Mass and administering sacraments. Until shortly before his death, he offered weekly Masses at both St. John the Baptist Church in Kenmore and at St. Martha's in Depew.

He especially treasured being invested in the Franciscan Friars habit and affiliation with their Holy Name Province. Among other honors are the Curé of Ars Award, the Bishop's Medal, St. John Neumann Award, Judge John D. Hillery Foundation Award, and the Christopher Award from the Catholic Youth Organization. His name is on the Wall of Honor at the Buffalo and Erie County Naval & Military Park.

He is survived by nieces and nephews.

Msgr. Lorenzetti will lie in repose at St. John the Baptist Church, 1085 Englewood Ave., Kenmore on Sunday, July 16, from 3-6 p.m. and then again on Monday, July 17, from noon-1:15 p.m. followed by a funeral Mass with Bishop Michael W. Fisher as the main celebrant.

# Buckeye Boys State hosts another successful blood drive

The motto of The American Legion's Boys State programs is "a week to shape a lifetime." Delegates at Buckeye Boys State in Ohio are helping shape others' lives.

"We always hold a blood drive on the Saturday before graduation," said Christie White, Americanism, and Children & Youth Coordinator for the Department of Ohio, who noted that Buckeye Boys State has teamed up with the American Red Cross for the event for over 15 years. "We choose this day because it is also parents' day, and we encourage parents to donate as well."

At this year's blood drive at Buckeye Boys State, 163 people donated a total of 192 units, including a record 46 power red donations. In power red donations, a special machine allows someone to safely donate two units of red blood cells during one donation.

Jean Richardson, an account manager with the Red Cross, noted the blood drives at Buckeye Boys State have been consistently successful even as participation in the program itself decreased post-Covid.

"I still think it's a huge, huge accomplishment to stay around the realm of 200 units each year," said Richardson, who noted that the blood drive in 2017 - Buckeye Boys State's first year at Miami University of Ohio — collected 211 units.

White noted that donations at Buckeye Boys State are the majority of the donations the Department of Ohio makes to the Red Cross blood drive. "Department headquarters holds blood drives every six weeks, but having a mass blood drive at BBS helps the Red Cross quickly," she said.

In addition to actual donations, Buckeye Boys State delegates help the Red Cross' "fantastic team" with the drive, White said.

"The BBS delegates in the State Department of Health do the check in. Like all of the aspects of Boys State, the blood drive is a teaching moment for these delegates. They get to work hand in hand with the Red Cross, assisting with appointments, entering data, (and) making sure everyone has snacks/water after they donate," she said.

"It's really great to see the boys committed to donating blood," Richardson said.

#### American Legion expresses support for pending legislation impacting VA benefits delivery, accountability

Legislation that would speed up Department of Veterans Affairs (VA) benefits process, improve its procurement and acquisitions efforts, increase security at VA facilities and add more teeth to existing accountability legislation received support during congressional testimony delivered by The American Legion on July 12. Joshua Hastings, the Legion's Veterans Benefits Policy Analyst in the Veterans Affairs & Rehabilitation Division, spoke before the House Committee on Veterans' Affairs Subcommittee on Oversight and Investigations on support for a variety of pending legislation, including the Legion's support for H.R. 196 – Expediting Temporary Ratings for Veterans Act. The bill would direct the Secretary of Veterans Affairs to modify VA's information technology systems to provide for the automatic processing of claims for certain temporary disability ratings, and for other purposes.

"The processing of temporary disability ratings has been identified as a backlog barrier for than a decade," Hastings told the committee. "Processing issues have led to substantial financial errors and contributed to unreasonable delays. The time it takes VA to grant such ratings ranges from a couple weeks to a couple months. There is no consistency.

"Veterans should receive their benefits in a consistent and timely manner. The American Legion believes increased automation can help reduce the claims backlog and deliver these benefits more efficiently."

A service-connected combat veteran, Hastings also stated Legion support for H.R. 4225 – VA Acquisition Review Board Act, which would establish the Acquisition Review Board of the Department of Veterans Affairs. He used VA's struggles with the rollout of its Electronic Health Record Modernization (EHRM) program as an example of why the legislation is needed.

"VA has a crucial mandate to ensure the procurement of goods and services is optimized to meet our nation's veterans," he said. "A 2022 (Government Accountability Office) report highlighted the VA's approach to acquisitions was varied and unstandardized, leading to oversight difficulties and subpar acquisition outcomes. Moreover, the VA's EHRM program mirrors this chaotic nature. In the wake of mismanagement and delayed problem resolution, its deployment has been stalled since June 2022, with costs escalating to an exorbitant \$59.12 billion.

"Creating a standardized and transparent framework for managing major VA acquisitions would heighten accountability and contribute to a more uniform acquisition process, boosting the efficiency of VA procurement and ultimately enhancing the provision of care for veterans. This legislation would also help to facilitate VA's ongoing efforts to modernize the EHRM system by ensuring the effective implementation of single system across VA and bi-directional connectivity to the Department of Defense. The American Legion believes this is essential in reducing further delays and unnecessary expenditures."

Support also was given for H.R. 4278 – Restore Department of Veterans Affairs Accountability Act, which amends the U.S. Code to modify personnel action procedures with respect to employees of the Department of Veterans Affairs.

"In 2017, Congress passed the VA Accountability and Whistleblower Protection Act to increase staff accountability and improve protection for whistleblowers. In August of 2021, it was found that VA misinterpreted this act by the United States Court of Appeals," Hastings said. "One of the protections assumed in this legislation was to mitigate the involvement of the U.S. Merit Systems Protections Board in certain decisions surrounding the employee. However, there was nothing written in the law to do so. This lack of clarity has allowed courts to dilute the VA secretary's authority to hold employees accountable, protect whistleblowers and keep veterans safe.

"Veterans deserve a process that delivers swift accountability for front-line workers, middle managers, and even senior executives. We must ensure VA leaders possess the tools necessary to hold bad actors accountable and protect those seeking a more productive and safer work environment."

And finally, Hastings voiced The American Legion's support for H.R. 3504 – VA Medical Center Security Report Act which directs the Secretary of Veterans Affairs to submit to both the House and Senate Committees on Veterans' Affairs an annual report regarding security at VA medical centers.

"The American Legion has also grown increasingly concerned that the safety of our veterans, staff and patients at VA facilities is in decline," Hastings said. "A recent OIG report highlighted severe understaffing, a lack of proper training and various security vulnerabilities. This includes an unsettling 33 percent average vacancy rate in officer positions across 70 medical facilities – and in some cases, this rate soared to over 60 percent. This has led to multiple serious incidents, including a bomb threat and firearms being discharged.

"The American Legion firmly supports legislation that ensures the safety of our veterans extends beyond providing quality medical care. We must do more to improve oversight of VA policing and set a foundation for enhanced safety protocols and more effective staffing strategies."

# Palou looking for fourth-straight INDYCAR win

After making it to Victory Lane three times since mid-May, the No. 10 American Legion Honda livery will get a break this weekend. But that doesn't mean the nation's largest veterans service organization won't be a part of this weekend's NTT INDYCAR SERIES race in Toronto.

Three Chip Ganassi Racing (CGR) drivers will feature American Legion branding during this weekend's Honda Indy Toronto street course race, including INDYCAR SERIES points leader Alex Palou.

Palou enters this weekend on an incredible roll, having won three straight races and four of the past five. He's built up a 110-point lead over second place and CGR teammate Scott Dixon and has finished 10th or higher in every race this season. In Toronto he'll debut a new livery: the blue and yellow No. 10 Journie Rewards Honda. A Palou win this weekend will give INDYCAR its first four-race win streak since 2006.

"Excited for Toronto this weekend, where we will break in the new Journie Rewards livery," Palou said via CGR media. "I think it will look great and shiny out there on the track. Obviously, I'm excited to race after a third win in a row at Mid-Ohio. It feels like we have been able to maximize things every race weekend this year in the No. 10 Honda."

Also featuring American Legion branding will be Marcus Ericsson in the No. 8 Huski Ice Spritz Honda and rookie Marcus Armstrong in the No. 11 Ridgeline Lubricants Honda.

Ericsson currently sits fourth in the INDYCAR SE-RIES points standings and has recorded eight top-10 finishes. "We're returning to a street course, which I enjoy driving at," he said. "I love street course racing in general. I think it's a lot of fun and we've had quite a few wins over the past couple years.

"It's always great going to Toronto, as it is a fantastic city and the atmosphere around the track is always great. We've got an exciting weekend ahead and I'm very much looking forward to it."

Armstrong has delivered strong performances on street courses this season, with a pair of eighth-place finishes and an 11th. He leads the Rookie of the Year chase with 130 points despite not racing on ovals.

"I've never been to Canada before, and it's my first time racing there obviously," Armstrong said. "The track looks really cool. I've always liked the idea of racing in Toronto since I was a kid. I really enjoyed watching the racing even though it's a different layout now.

"I feel like I've been performing well on street tracks this year. The car feels really good, especially on this type of track, and I feel very confident heading into the weekend despite seeing it for the first time."

This weekend, INDYCAR drivers can look forward to a tight 11-turn, 1.786-mile Exhibition Place street circuit that offers great views of downtown Toronto and often leads to cars attempting to squeeze past each other in turns. The long frontstretch leading into the Princes' Gate at Turn 1 and the Lakeshore Boulevard straight leading into a hard 90-degree right-hander at Turn 3 are the best places for overtaking.


#### Honda Indy Toronto notes (via INDYCAR)

• The Honda Indy Toronto will be the 10th race of the 2023 season. There have been five different

winners in nine NTT INDYCAR SERIES races this season. Marcus Ericsson (Streets of St. Petersburg), Josef Newgarden (Texas Motor Speedwav and Indianapolis 500), **Kyle** Kirkwood (Streets of Long Beach), Scott McLaughlin (Barber Motorsports Park) and Alex Palou (Indianapolis Motor Speedway Road Course-1, Streets of Detroit, Road America, and Mid-Ohio Sports Car Course) have all won in 2023. The modern record (1946-present) for most different winners in a season is 11 in 2000, 2001 and 201

- The Honda Indy Toronto will be the 37th INDYCAR SERIES race held on the streets of Toronto's Exhibition Place. Scott Dixon earned his fourth Toronto victory in 2022.
- Scott Dixon is the winningest active INDYCAR • SERIES driver at Toronto with four victories (Dixon won both races in 2013, and in 2018 and 2022). Michael Andretti has the most wins at the track with seven. Dixon, three-time Toronto winner Will Power (2007, 2010, 2016), Josef Newgarden (2015, 2017) and Ryan Hunter-**Reav** (2012) are previous race winners entered this year. Drivers who have won poles at Toronto entered in this year's race are Will Power (2011, 2015), Scott Dixon (2013 Race 2, 2016), Helio Castroneves (2000), Josef Newgarden (2018) and Colton Herta (2022). The polesitter has won the race seven times since the first race in 1986, most recently by Simon Pagenaud in 2019. From 2009-2019, the eventual NTT INDYCAR SERIES champion won the Toronto race six times. Dario Franchitti won in 2009 and in 2011. Rvan Hunter-Reav won in 2012, Scott Dixon swept both races in 2013 and won the single race in 2018, and Josef Newgarden won in 2017. Seven other drivers have claimed the INDYCAR SERIES championship in the same season they won at Toronto: Bobby Rahal (1986), Al Unser Jr. (1990), Michael Andretti (1991), Alex Zanardi (1998), Cristiano da Matta (2002), Paul Tracy (2003) and Sebastien Bourdais (2004).
- Twenty-three drivers entered in the event have competed in past INDYCAR SERIES races at Exhibition Place. Helio Castroneves, Scott Dixon, and Will Power (16) have made the most starts at Toronto among the entered drivers. Eleven entered drivers have led laps at the track (Dixon 240, Power 162, Josef Newgarden 120, Castroneves 101, Rvan Hunter-Reav 36, Gra-Rahal 29, Rinus VeeKay 18, Colton ham Herta 17, Pato **O'Ward** 3 and Felix Rosenqvist 1).

- Chip Ganassi Racing has won eight times at Toronto: Michael Andretti (1994), Alex Zanardi (1998), Dario Franchitti (2009, 2011) and Scott Dixon (2013 both races, 2018, 2022). Team Penske has five wins at the track: Paul Tracy (1993), Will Power (2010, 2016), Josef Newgarden (2017) and **Simon** Pagenaud (2019). ### From Legion Baseball star to MLB scout

Twenty years ago, Jay Heafner was a star player on an American Legion World Series runner-up, was two years away from winning a top college honor and three years away from beginning his professional baseball career.

Now 39, Heafner's current job is watching amateur baseball players — including going to American Legion baseball games — as a scout in the Texas Rangers' organization.

It's a career that Heafner sought out soon after his official playing days ended. Then, Heafner had started his post-baseball career working for a bank in Charlotte.

"I just wasn't good at it," Heafner recalls. "And I knew I still loved baseball."

Luckily for Heafner, he had stayed in touch with many from his baseball past, among them Scott Servais.

Now in his eighth year as the Seattle Mariners' manager, Servais could relate to Heafner's situation.

After Servais' 11-year major league career, he would join the Texas Rangers' front office working in player development. That was Servais' job in 2008 when he gave Heafner his chance to change jobs.

"I had always stayed in touch with Scott Servais through emails and texts," Heafner said. "Then he once said, 'We may have a scouting position available. You want me to pass your name along?' I said, 'Yeah sure."

Heafner has been with the Rangers ever since, first living in New Jersey in charge of scouting the Northeast and now in the Charlotte, N.C., suburb of Indian Trail. "This year is my 15th major league draft, and I've always enjoyed it," Heafner said.

Heafner's job is to scout players in his region and forward those assessments to his superiors.

Among those Heafner personally scouted that were drafted by the Rangers are current Chicago Cubs pitcher Kyle Hendricks, current Tampa Bay Rays pitcher Jeffrey Springs and pitcher Owen White, who made his major league debut earlier this season for the Rangers.

"You can't help but become a little emotionally attached to the process and the players that you sign," Heafner said. "But it's also got to be the right thing for the Rangers and what the organization needs. Your goal is to get the best value for your club." As a player, Heafner helped his West Lincoln High School team in Vale, N.C., to its first 20-win season and state playoff appearance in the spring of 2000 before beginning a four-year American Legion Baseball career with perennial power Cherryville Post 100 where he finished second all-time in hits.

In 2003, Heafner was the leadoff batter, shortstop, and pitcher for Cherryville's American Legion World Series runner-up team to Rochester, Minn. And while Heafner missed the championship game loss after suffering a broken toe in the semifinals, he was named to the 2003 ALWS all-tournament team.

Heafner's success continued at Davidson College where he was named 2005 Southern Conference player of the year when his .448 batting average finished second in the nation. He finished his Wildcats career second all-time in career hits, first in career saves and was the school's first (and to date only) preseason All-American selection.

A 2020 Davidson Sports Hall of Fame inductee, Heafner was selected in the 23rd round of the 2006 major league draft by the Rangers; Heafner spent two seasons in the Texas organization as an infielder.

## Vintage aircraft, Army parachutists scheduled for USAA Military **Appreciation Day at American Legion World Series**

The schedule for the 96th American Legion World Series will again include USAA Military Appreciation Day, on Aug. 12 at Veterans Field at Keeter Stadium in Shelby, N.C.

In conjunction with the day, three T-28 Warbirds from the Museum of Flight will fly over the stadium and the U.S. Army Golden Knights parachute team will perform a 35-minute program between the second and third games of the day, approximately 6 p.m. The T-28s - single-engine, vintage aircraft - generated excitement in 2022, and the pilots are eager to return. These World War II-era fighters are among the fastest propeller-driven airplanes ever built.

The U.S. Air Force, the U.S. Navy and the U.S. Marine Corps used various models of the T-28 as trainers beginning in the 1950s; the military took the planes out of service as trainers in the 1980s. The planes also were used as counter-insurgency aircraft, primarily during the Vietnam War. The T-28 pilots will perform a flyover every day of the six-day tournament, Aug. 10-15.

The T-28s and the Golden Knights' plane will be on public display from 9 to 11 a.m. Aug. 12 at the Shelby-Cleveland County Regional Airport.

The two Golden Knights demonstration teams travel the United States (and occasionally overseas), performing for public audiences at venues ranging from relatively small civic events to nationally and internationally televised events, such as Monday Night Football games, NASCAR races, and large international airshows. The two 12-member teams travel around 240 days per year.

Two Blaze Battalion JROTC units from Blackman High School in Murfreesboro, Tenn., will post the colors at all games Aug. 10-12. The award-winning Battalion is returning for the third consecutive ALWS.

"We are absolutely thrilled to welcome back the Museum of Flight's warbirds, the U.S. Army Golden Knights and the Blaze Battalion JROTC to this year's event," said Robert Farrow, the ALWS Executive Committee member who coordinates aerial events. "It's an honor to showcase these iconic aircraft and the remarkable talents of the Golden Knights. We can't wait to share this experience with our visitors. The ALWS focuses on excellent baseball, but these additional events create another level of excitement."

General admission tickets for the ALWS are available online at AmericanLegionWorldSeries.com. Dav passes will be available at the Keeter Stadium ticket office once games begin.



Legion to Senate: drop the hold July 12, 2023

Dear American Legion Family members and friends,

When I visited Pearl Harbor last December, I had the honor of speaking with survivors of the infamous attack. The lesson that most Pearl Harbor veterans expressed to me over the years is that America must always be prepared.

Unfortunately, America's readiness to defend its citizens is unnecessarily harmed due to the actions that are occurring in the U.S. Senate. Really inaction is a better word.

Since Monday, the U.S. Marine Corps has been without a confirmed commandant. It is the first time that the Marines have not had an authorized commandant in 164 years. In fact, 16 general officers in the U.S. Marine Corps have had their promotions put on hold due to a legislative maneuver by a single U.S. senator. The holds are not because they are unqualified but because the senator objects to totally unrelated policies that these officers had nothing to do with.

Other members of the Joint Chiefs of Staff will retire in the next two months, leaving vacancies in the highest military positions. The people aspiring to these billets will be in good company, as more than 260 general and flag officers so far in all our military branches have had

their promotions put on hold because of this. The U.S. Air Force alone has 99 general officer promotions on hold.

# **National Emergency Fund**

Considering the recent deadly tornadoes and other declared natural disasters throughout the country, as well as numerous other current, past, or future declared natural disasters, we are sending this information as a reminder of the National Emergency Fund (NEF) grant funds application process and availability. **Please review application and Power Point video regarding completion of the NEF Grant Application instructions carefully** and share as you deem necessary within your department. The most frequent problem is our member applicants sending incorrect and incomplete grant applications directly to national, where we in turn must forward those grant applications to the department headquarters for proper completion and investigation.

#### If any of your American Legion posts perform duties in disaster relief efforts, please let us know about this.

Please review the NEF Grant Application carefully, and remember, until there's an emergency declaration for a natural disaster in place (federal, state, or local), NEF can't help until one is called. If a declaration happens, ensure that the applicant is current on their membership prior to the disaster and at the time of application submission, provides photos, receipts, and any insurance paperwork. FEMA statements are good too. Statements from American Legion Post/District/Department officers or community leadership is encouraged to reinforce the grant application. Ensure application is completely filled out, or it could be sent back to you for more information. This is all outlined on the application and is provided for on the instruction sheet.

NEF does not provide for repairs or replacement of lost or damaged items in the primary home of residence. If the destroyed property is owned by the member, but he/she does not physically live there, that is not covered. Vehicles or outbuildings are not covered. That is what insurance should cover. If available, provide copies of insurance determination, if any. If the home is rented, renters insurance information should be provided, if any. Call or e-mail me or Mark Woodsmall (317-630-1265) for any clarifications.

For American Legion posts, the only things covered are post programs that might sustain losses pertaining to the intent of the Four Pillars of The American Legion. Losses from the social quarters and/or restaurant of the post are not covered. A copy of the most recent Consolidated Post Report (CPR) needs to be attached. A statement from post/district/department officers or community leaders as to how the losses in the post is very helpful if available. Photos of damages are needed for best determination. Insurance documents should be provided.


You can mail, fax (317-630-1413) or scan/e-mail the application and any attachments (photos, receipts, other supporting documents) to <u>ia@legion.org</u>. Staff will process from there. If approved by the National Adjutant, a check will be cut from Finance and mailed in a timely fashion to the department adjutant to disburse to the member or the post. Address to mail grant applications is:

Again, if a National Emergency Fund application comes to us directly from the member, we will scan/email back to the department adjutant for your recommendation. Remember, you and your leadership are "boots on the ground," so the department has to make the best determination for recommended grant amount to the national organization.

The American Legion's Temporary Financial Assistance Program is also ready to assist American Legion eligible veterans with minor children in the home (18 or younger) who need financial help to pay for shelter, food, utilities, and medical expenses. Please make sure that all pertinent documentation is included in the packet as well as the investigator's report. Missing documentation will slow down the process and may result in the application being denied.

# Navy secretary signs order mandating mental health care, confidential evaluations

The U.S. Navy and Marine Corps have apparently become the first U.S. service branches to implement the



Brandon Act, a set of policies that provide service members with a confidential evaluation and greater access to mental health care.

Secretary of the Navy Carlos Del Toro signed the in-

struction Monday, according to the parents of Brandon Castera and a USNI News report Tuesday. President Joe Biden signed the measure into law in December 2021 as part of the fiscal 2022 National Defense Authorization Act.

The act is named for Petty Officer 3rd Class Brandon Castera, an aviation electrician. Castera, 21, died by suicide June 25, 2018, at Naval Station Norfolk, Va. A command investigation found that a combative and toxic leadership contributed to his death. Brandon's parents, Teri and Patrick Castera, two months after his death started a push to get the measure passed, an uphill battle of phone calls and trips to the Pentagon, Patrick Castera told Stars and Stripes by phone Wednesday.

"He will forever be saving lives and his death meant something, as tragic as it was," his father said. "I know he's smiling at us. He had a smile and made everyone want to smile."

The Brandon Act allows service members to seek confidential help for any mental health issue, at any time, in any environment, thereby reducing the stigma associated with seeking mental health treatment.

The act requires a mental health evaluation as soon as service members self-report, according to thebrandonact.org, a website the Casteras created. The Brandon Act "will also allow Americans serving in uniform to seek help confidentially and, if necessary, outside of the chain of command," according to the website.

The measure also mandates annual training from the Department of Defense on recognizing members who may need a mental health evaluation.

Under the law, commanders and supervisors must ensure that service members understand the procedure for requesting a mental health evaluation, ensure they are referred as soon as possible, maintain privacy protections, and not seek the results of evaluations, among other requirements.

Del Toro called the Casteras as they drove to their Peoria, Ariz., home with word that he had signed the order to implement the act, Patrick Castera said. Del Toro read the policy over the phone and said he was signing it on the spot, Castera said. The secretary later sent a photo of the signed document to the Castera family.

"It brought tears to our eyes knowing that he actually signed the act into Navy and Marine law," Teri Castera said. "It was thrilling."

The Casteras posted the news Tuesday on The Brandon Act Facebook page, where a flood of comments followed.

"This is amazing," Petty Officer 2nd Class Emilie Nielson, a gunner's mate, wrote. "I can't tell you how many hoops I had to jump through to seek help for my own mental health through the military. This is a huge step in the right direction."

Two months ago, Nielson, of Albuquerque, N.M., was stationed on the amphibious transport dock USS Mesa Verde, when she experienced difficulty getting help for anxiety and depression, she told Stars and Stripes via Facebook Messenger on Wednesday.

"When I was on the ship, the big issue I faced was getting an appointment," Nielson said. The process involved getting screened by medical specialists who set up a doctor appointment for a referral to a therapist, she said. The process could take weeks or months.

"There's a saying the Navy has: 'Ship, shipmate, self,' which to me is completely backwards," Nielson said. "If I can't take care of myself first, how can I take care of my shipmates or my ship? When I told my command about my view on the saying I received some pushback."

The Navy recorded 72 suicides in fiscal 2022, according to the Defense Department.

"This is to erase the stigma out there about mental health, it is OK to seek help," Patrick Castera said.

### Biden says 3,000 Reserve troops can be sent to Europe to support NATO, Ukraine

President Joe Biden signed an executive order Thursday that makes as many as 3,000 American reservists available to go to Europe in support of NATO efforts amid the ongoing war in Ukraine.

The purpose of the order, Biden said, is to better support Operation Atlantic Resolve, a mission that launched almost a decade ago after Russia annexed Crimea from Ukraine.

"Since 2014, U.S. European Command has provided combat-credible forces for rotational deployment to Europe ... to demonstrate good commitment to NATO," Army Lt. Gen. Douglas Sims, director of operations for the Joint Staff, told reporters Thursday. "This reaffirms the unwavering support and commitment to the defense of NATO's eastern flank in wake of Russia's illegal, unprovoked war on Ukraine."

In Biden's order, he said the move making thousands of Reserve troops available is needed to back up American forces already involved in the defensive operation. "Reserve mobilizations under this authorization are not to exceed 3,000 total members at any one time, of whom not more than 450 may be members of the Individual Ready Reserve," Biden said in a letter informing Congress of his order. "These Reserve component forces are to augment the active forces ... to enhance the United States' ability to sustain its heightened level of presence and operations."

The Pentagon stressed the order doesn't simply send 3,000 more troops to Europe, but rather it only makes reservists available to go if EUCOM decides they're needed. For example, Sims said commanders in Europe might decide a Reserve unit is better suited to handle certain tasks than active-duty troops who are already there.

Even before Russia's invasion of Ukraine in February 2022, the United States had put thousands of additional American troops in areas neighboring, or near, Ukraine — such as Germany, Poland, and Romania to support NATO's eastern flank. Biden's administration has also given Ukraine tens of billions of dollars in military aid at the same time, including an \$800 million package last week.

"The United States European Command is preparing to use new authorities in support of Operation Atlantic Resolve, in continuation of U.S. commitment to NATO collective security, peace and stability," Navy Capt. Bill Speaks, a spokesman for U.S. European Command, said Thursday. "This will not change current force posture levels in Europe."

The Pentagon also said Atlantic Resolve is now being designated as a "contingency operation," which is a move to add operational flexibility and troop benefits. "It unlocks capabilities and authorities that enables us to provide better support," said Air Force Brig. Gen. Pat Ryder, the Pentagon's top spokesman. "This includes things like … personnel related entitlements that give activated reservists the same benefits as active-component personnel."

Biden's order comes after he met this week with Ukrainian President Volodymyr Zelenskyy at the NATO summit in Lithuania. During the summit, he and other NATO leaders agreed to expedite Ukrainian membership and said Kyiv will receive an invitation once certain conditions are met, such as improved defense standards and equipment.

"Ukraine's future lies at NATO," Biden said Wednesday at the conference, where the United States and G7 nations Japan, Canada, Germany, France, Britain, and Italy issued a joint declaration of support for Ukraine. "We are going to help Ukraine build a strong capable defense across land, air and sea."
