Our membership cards turned in through November 20<sup>th</sup> show that **the SAL is now 17,164 members ahead of where we were just one year ago!** Last year we set records, and it looks like this year we will be setting new ones all in service to our Veterans!

As some of us prepare for the cooler winter weather will understand, momentum no matter how small is still momentum and it will snowball and get bigger and bigger until it shows that we are making massive actions without even thinking about it! **Action is momentum!** The difference between our dreams and reality is called action.

We are entering into what in the past has been a slower membership turn-in season. The holidays will soon be upon us, but we cannot stop the movement we have started. No excuses, never give up, work hard, be positive, start doing and keep going! **Continue to trust the process and there is no way we can be stopped!** 

Now our numbers...

The Central Region jumped 5.58% since my last report!

Leading the Parade this time is the Detachment of Michigan with an impressive jump of 7.10%. Right behind them were the detachments of Indiana and Minnesota with gains of 6.50% and 6.28% respectively. Wisconsin and Illinois followed with increases of 5.43% and 5.15%. Ohio and West Virginia added over 3% each and Kentucky grew by almost 2%. We are still in 3<sup>rd</sup> place nationally but with this report we are 3.37% ahead of where we were last year! Four of our detachments have already reached the 45% and above mark! An interesting fact to take note of is that the Central Region is the only region with five detachments that have over 11,000 members each and look at what we have accomplished!

#### 'I think every boy in America ought to go to Boys State'

A tradition at American Legion Boys Nation is that exemplary delegates who aren't elected to one of the program's four top offices may be invited back for the next three years to serve as junior counselors.

U.S. Navy Commander Hunter Scott was invited back for just one year as a "JC" – not by choice – but that experience provided a lesson in leadership he would never forget.

"(I learned) for me to be an effective leader, I first need to be comfortable with myself," Scott said during a July 2023 return to Marymount University — home of Boys Nation since 1986. "And then I would have the intention to not focus on myself but to focus on the people that I would be responsible for leading."

Scott, a special assistant to Chairman of the Joint Chiefs of Staff, accompanied then-Chairman Gen. Mark Milley to Marymount <u>for an unprecedented visit</u> <u>to Boys Nation</u>.

The visit also gave Scott a chance to reminisce about his experience at Florida American Legion Boys State and American Legion Boys Nation in the summer of 2002, as well as his one year as a Boys Nation staffer in 2003.

"When I came to Boys Nation in 2002, I was, I think, a very good delegate. I loved our country, still do. I love our government. I love our military. I love all aspects of living a life of service. And so, when I got to Boys State and then was selected to go to Boys Nation, I took the program very seriously; I loved every part of it. I was fully engaged. I introduced legislation. I was involved in all the conversations. I always tried to sit in the front, ask engaging questions, develop relationships with the other boys ... I loved it. And I think the counselors took notice of that, too, because I was invited back to be a counselor."

That chapter of his American Legion Boys Nation story did not turn out as well.

"I was a terrible counselor. Because, upon many years of being able to reflect on this, of my own insecurities. I wanted to be well liked and to be thought of as cool more than I wanted to be, to use Navy words, 'in command,' or responsible for good order and discipline and make sure these boys got the most out of the program. So, I didn't enforce basic discipline standards, I lost control of the group, my group was rowdy and undisciplined, and by the time I realized that I kind of needed to bring in the reins a little bit, it was too late." Given the effectiveness of the lesson he learned from his year as a Boys Nation junior counselor — plus his cherished memories of his time at Florida Boys State and as a Boys Nation delegate — Scott remains an ardent supporter of the programs.

"I think every boy in America ought to go to Boys State. And if you can, Boys Nation. They are really, really incredible programs. It doesn't matter what your dreams or goals are; for me, you can see a direct line to Boys State or Boys Nation, and my path as an officer in the military. Whether you want to go into business or you want to be in healthcare, or you want to be engaged in your community in some regard, I think Boys State makes a lot of sense, because we all

feel the decisions of our government. So, whether we are directly involved, we've got to know how the process works."

With ongoing recruiting shortfalls, Scott also encouraged young people to be open-minded about considering the military as a career.


"The longer I've been in, the more I love it," Scott said while acknowledging he faced an initial "culture shock" when he first entered the service. "One, it gives a real sense of purpose to your life. We all take an oath to support and defend the Constitution; I take that oath very seriously. It is the second most important oath I have taken, the first being to my God. Two, I work with really incredible people, all day, every day. "... I love the sense of service, I love the people, and I love the mission that we do. Being able to protect our democracy and fight to preserve our values all over the world, that is really important to me. I just recommend everyone in high school or college, or at any point, be open-minded to the military, because it is a really, really wonderful life."

#### Changes coming to American Legion newsletter schedule

The American Legion Media & Communications team is adjusting its schedule for its newsletter distribution, starting the week of Nov. 27. (Also, note that due to the Thanksgiving holiday there will not be an Online Update on Nov. 24.)

Starting the week of Nov. 27, these are the changes:

- The American Legion Online Update will move from three times a week to two, going out each Monday and Thursday. What subscribers need to know: If you currently subscribe to both Online Update and Thank You Thursday (TYT), a link to TYT will be included in your Thursday Online Update and you will no longer receive the Thank You Thursday email. If you receive Thank you Thursday but not Online Update, you will continue to receive TYT as normal.
- The Commander's Message, which currently is distributed on Wednesdays, will be sent on an asneeded basis.
- Dispatch will move to twice a month starting in January. The Dispatch, which is packed full of resources, training materials, etc., will continue to provide such content to subscribers but now in a more-timely fashion.

Legion Baseball alumni Holliday, Sheffield on Hall of Fame ballot

Two former American Legion Baseball players are among the 26 players on the Baseball Writers Association of America (BBWAA) ballot for the Baseball Hall of Fame Class of 2024 — one in his first year of eligibility and one in his last.

Matt Holliday (Stillwater, Okla.) and Gary Sheffield (Post 248/Tampa, Fla.) are under consideration for induction into the Hall of Fame in Cooperstown, N.Y. Voting results will be announced Jan. 23, with the induction ceremony taking place during Hall of Fame weekend July 21, 2024.

Holliday played 15 seasons in the major leagues with Colorado, Oakland, St. Louis, and the New York Yankees. A seven-time All-Star and four-time Silver Slugger Award-winning left fielder, he was the MVP of the 2007 National League Championship Series with the Rockies and was a member of the Cardinals' World Series champions in 2011. In 2007, he also led the NL with a .340 batting average, 216 hits, 50 doubles, 137 RBIs and 386 total bases. Holliday finished his career with a .299 batting average, 316 home runs and 1,220 RBIs. This is Holliday's first year of eligibility for the Hall of Fame.

Sheffield is in his 10th and final year on the BBWAA ballot. He played 22 seasons with Milwaukee, San Diego, Florida, the Los Angeles Dodgers, Atlanta, New York Yankees, Detroit, and the New York Mets. A nine-time All-Star, Sheffield won five Silver Slugger Awards — one at third base and four as an outfielder. He helped the Marlins win the 1997 World Series. A career .292 hitter, Sheffield finished his career with 509 home runs and 1,676 RBIs.

Holliday and Sheffield join former major league managers Jim Leyland (Post 183/Pemberville, Ohio) and Lou Piniella (West Tampa) as Legion Baseball alumni under consideration for the Hall of Fame Class of 2024. The Contemporary Baseball Era Committee will decide Dec. 3 on which former managers may be headed to the Hall.

Leyland won 1,769 games in 22 seasons managing the Pirates, Marlins, Rockies, and Tigers, and led the Marlins to the 1997 World Series title. He was a threetime Manager of the Year Award winner.

Piniella won 1,835 games in 23 seasons as manager for the Yankees, Reds, Mariners, Rays and Cubs. He managed the Reds to the 1990 World Series title and was a three-time Manager of the Year.

#### Hollywood veterans inspire others into film industry

Hollywood actors Julia Ling and Hiram Murray have their personal stories for joining the U.S. military. Navy Reservist Lt. Ling knew she wanted to serve in response to being thankful for growing up in America and for her freedom after watching her parents struggle through the painful memories of slavery and genocide in their home country before fleeing to the United States. Murray was attending film school in his home state of New York and working with the New York City Police Department when "9/11 happened on my watch, in my back yard." That's why he joined the Marine Corps.

Ling and Murray, members of American Legion Hollywood Post 43, have combined their two passions of acting and military service into a mission through <u>Veteran</u> <u>Powered Films</u> (VPF). They join <u>this week's episode of</u> <u>The American Legion Tango Alpha Lima podcast</u> to discuss VPF.

Veteran Powered Films hires and casts veterans, invites veterans to be a part of the movie-making industry through roles on screen or behind the camera, and promotes veteran-owned businesses. And VPF is helping to reduce veteran suicide by giving veterans a purpose again.

For Ling, who launched her acting career in "Buffy the Vampire Slayer" and has starred in the TV series "Chuck," "E.R.," "Grey's Anatomy" and "House," VPF started "from a really dark place. I was actually really depressed at the time, and we learned that a lot of veterans were taking their lives. It was the inspiration, the idea that we want to help stop veteran suicide by involving (and inspiring) veterans in movie-making by hiring and casting them." That mission has grown to helping "veterans as much as we can – anything that will help give that little spark," Ling added. VPF has a new trailer called "<u>Homestead</u>" that is a family drama horror starring Murray.

Murray said the movie industry and military service are connected, with both having a mission. And VPF wants to show veterans that connection.

"It's a collaborative experience ... you know one team, one fight. We all have a mission," said Murray, who has starred in roles on Fox's "Touch" starring opposite Kiefer Sutherland and "Lethal Weapon" starring opposite Damon Wayans. "When you're on set the mission is to get the project done. When you're in the military, you're on a team and you have to know the man in front of you's job and the man behind you's job in case something goes wrong. You can still pick up and carry on to accomplish that mission. It's the same thing on a movie set."

Through VPF, Ling and Murray are also closing the gap between veterans and civilians by showing that "the only thing that separates us is that we chose to take up the call and serve our country but we're still husbands, we're still brothers, fathers, sisters," Murray said. "The beauty of being in the military is that we take all different walks of life, and we combine them together to make one unit," said Murray, adding that he's a father of six, a former law officer, from New York and has Caribbean heritage. "... there's so many stories there, don't put me in a box. I'm more than just my title of United States Marine."

Also in this episode, co-hosts Amy Forsythe and Ashley Gutermuth discuss topics including:

- Banners honoring veterans may be coming down for good due to costs a local Legion post can no longer fund.
- U.S. veterans use art for female Afghan soldiers who fled their country to help process their pain features a recent guest.
- A USAA survey shows we should do more than simply thank our veterans for their service.
